Content of the report:

The Management Board of HAWE S.A. with registered office in Warsaw (hereinafter referred to as "Company") hereby gives public notice that yesterday (i.e. 14 February 2012) the Company received a notification of transactions on the Company's shares which were performed by the Brokerage House of Bank DnB NORD Polska S.A. (hereinafter referred to as "Brokerage House") on the basis of the Agreement on the purchase of own shares concluded between the Brokerage House and HAWE Telekom Sp. z o.o., in which HAWE S.A. holds 100 per cent of shares in the share capital.

The Brokerage House, executing the own share buyback programme, pursuant to the Resolution No. 24 of the Ordinary General Meeting of Shareholders of HAWE S.A. of 28 June 2011 and Article 362(1)(8) in relation to 362(4) of the Commercial companies code, acting on its own behalf, purchased between 6 and 10 February 1,321,632 shares in the Company in its own account with an intention to resell them to the Company.

A summary of the data concerning these transactions constitutes an appendix to this report.
